3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH), to**
4 **accept and expend a new grant in the amount of \$157,541 from the California**
5 **Department of Transportation (CDOT) to improve pedestrian safety in Bayview Hunters**

9 WHEREAS, SFDPH has applied for and been awarded a grant in the amount of
10 \$157,541 from CDOT to improve pedestrian safety in Bayview Hunters Point, San Francisco;
11 and,

12 WHEREAS, As a condition of receiving the grant funds, CDOT requires the City to
13 enter into an agreement (the "Agreement"), consisting of the SFDPH Application to CDOT for
14 these funds and a copy of the State Service Contract request, which are on file with the Clerk
15 of the Board of Supervisors in File No. 051914; which is hereby declared to be a
16 part of this resolution as if set forth fully herein; and,

17 WHEREAS, The grant budget includes a provision for indirect costs of \$3,757; now,
18 therefore, be it

19 RESOLVED, That SFDPH is hereby authorized to accept and expend a grant in the
20 amount of \$157,541 from CDOT; and, be it

21 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the
22 grant funds in accordance with the requirements set forth in the Agreement, pursuant to San
23 Francisco Administrative Code section 10.170-1; and, be it

24 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
25 agreement on behalf of the City; and, be it






