WHEREAS, Each year the City and County of San Francisco applies for Community Development Block Grant ("CDBG") funding under Title I of the Housing and Community Development Act of 1974, as amended; and.

WHEREAS, The Mayor's Office of Community Development ("MOCD") prepared proposals for the acceptance and expenditure of CDBG funds for fiscal years 1998/99 and 2000/01 through 2004/05, and the Board of Supervisors approved the acceptance and expenditure of such funds in accordance with the MOCD proposals by Resolution Nos. 90-99, 349-00, 324-01, 285-02, 301-03, and 288-04 respectively (the "Authorizing Resolutions"); and.

WHEREAS, MOCD has closed out numerous grants made pursuant to the Authorizing Resolutions, and as a result MOCD has recaptured CDBG funds in an amount equal to One Million Four Hundred Forty-seven Thousand Six Hundred Five Dollars and Forty-nine Cents (\$1,447,605.49) (the "Recaptured Funds"); and.

WHEREAS, MOCD has administrative funds in the amount of One Hundred Seventeen Thousand Nine Hundred Eleven Dollars and Seventy Cents (\$117,911.70) from fiscal year 2003/04 which have not been expended and are available (the "Carry-Over Funds"); and,

WHEREAS, In a settlement agreement with Apartment Investment and Management Company ("AIMCO") approved by the Board of Supervisors by Ordinance No. 268-04 (File No. 041342), AIMCO agreed to contribute One Million Dollars (\$1,000,000) towards the

FURTHER RESOLVED, That MOCD is hereby authorized to submit such documentation and certifications as may be required by the U.S. Department of Housing and Urban Development to effectuate the above reprogramming of CDBG dollars.
