11	Be it ordained by the People of the City and County of San Francisco:			
12				
13	Section 1. Chapter 5, Article XXXVIII, of the Administrative Code is hereby amended			
14	by revising Section 5.38-8, to read as follows:			
15	SEC. 5.38-8. SUNSET DATE.			
16	Unless the Board by ordinance extends the term of the Committee, this Article XXXVIII			
17	shall expire by operation of law, and the Committee shall terminate, on January 1, $\frac{2025}{2027}$.			
18	In that event, after the sunset date, the City Attorney is authorized to cause this Article XXXVIII			
19	to be removed from the Administrative Code.			
20				
21	Section 2. Interim Seat Retention.			
22	(a) Notwithstanding the provisions of Administrative Code Sections 5.38-4 and 5.38-5,			
23	all members serving on the Cannabis Oversight Committee as of January 1, 2025, shall retain			
24	their seats until the effective date of this ordinance.			
25				

(b) Following the effective date of this ordinance, members of the Cannabis Oversight
Committee shall continue to retain their seats until the designated end date of their respective
terms. If the designated end date would otherwise be after January 1, 2025, but prior to the
effective date of this ordinance, the effective date of this ordinance shall be deemed the end
date, in accordance with subsection (a).

- (c) Neither subsection (a) nor subsection (b) precludes removal of a member of the Cannabis Oversight Committee in accordance with Administrative Code Section 5.38-5(a) or (c), as may be applicable.
- (d) This Section 2 shall not override any ordinance that amends provisions of Administrative Code Chapter 5, Article XXXVIII, regarding membership on the Cannabis Oversight Committee.

Section 3. Effective Date; Retroactivity.

- (a) This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.
 - (b) Upon its effective date, this ordinance shall be retroactive to January 1, 2025.
- (c) It is the intent of the Board of Supervisors that the Cannabis Oversight Committee continue to operate in the interim period from January 1, 2025, to the effective date of this ordinance.

Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal

Existing Law

The sunset date for the Cannabis Oversight Committee is currently January 1, 2025.

Amendments to Current Law

This ordinance would retroactively extend the sunset date for the Cannabis Oversight Committee from January 1, 2025, to January 1, 2027, and would provide that any members serving on the Committee as of January 1, 2025, would continue to hold their seats until the effective date of the ordinance.
