Hi Connie,

Last night I learned from a neighbor that lives across the street from Tia Margarita that their parklet on 19th Ave caught on fire early Tuesday morning. Two fire trucks showed up around 3:30/4am to put out the fire. They are currently closed for maintenance until Aug 7. I live around the corner on Clement above Lokma restaurant and this is a safety issue that has concerned me since these parklets were built last year. Had this fire been larger, it could have easily jumped across the street and escalated quickly.

I expressed my concern to you a few months ago about how these parklets have impacted me and nearby residents, and this is a clear example of how easily these wooden structures can catch on fire, seriously endangering both the residents who live above & adjacent, as well as the business. Unfortunately, I think this will be one example of many....

I would also like to add here that I'm very disappointed that you and other supervisors voted unanimously to approve the Permanent Shared Spaces program. I understand that it's been a lifeline to keep restaurants in business during the pandemic. However, the permanency ONLY

benefits restaurants, giving them additional public real estate for the dime on the dollar, while it doesn't consider how residents, families and many businesses will be negatively impacted in the long term.

I have lived in this city for over 20 years and have been involved in work and many projects to improve the community and move the city forward. This is not an example of progress. Shouldn't the residents and other businesses also have a say in all of this? Restaurants aren't the only game in town!
