7 Section 1. Part II, Chapter V of the San Francisco Municipal Code (Health Code) is hereby  
 8 amended by amending Section 128, to read as follows:

9 Sec. 128 PATIENT RATES. The Board of Supervisors of the City and County of San Francisco does  
 10 hereby determine and fix the proper reasonable amounts to be charged to persons for services furnished  
 11 by Department of Public Health as follows, which rates shall be effective for services delivered as of ((July  
 12 1, 1998)) July 1, 1999.




