6 WHEREAS, United Against Hate Week emerged from a United Against Hate poster
7 campaign created by Bay Area cities in response to white supremacist rallies in Berkeley and
8 San Francisco in 2017; and

9 WHEREAS, United Against Hate Week is an annual event aimed at promoting unity,
10 understanding, and the rejection of hate and discrimination with events such as facilitated
11 anti-bias training, how to be an ally training, bystander training, practicing standing up to
12 bigoted remarks or hate speech, in person or online; and

13 WHEREAS, United Against Hate Week, scheduled for November 12, through
14 November 18, 2023, provides an opportunity for San Franciscans to join Californians across
15 the state to stand against hate and bigotry, and to celebrate our shared commitment to
16 inclusion and acceptance; and

17 WHEREAS, Dozens of California cities and counties are participating through rallies,
18 community campaigns and public events such as unity walks, unity-theme sports events, and
19 creating and promoting United Against Hate theme booklists; and

20 WHEREAS, Members of the public can participate by displaying United Against Hate
21 posters, joining an anti-hate walk, or working with local professors, community leaders, and
22 subject matter experts to organize a teach-in on a topic that is relevant to United Against Hate
23 Week; and

1 WHEREAS, The Board of Supervisors of the City and County of San Francisco hereby
2 recognizes United Against Hate Week, to be held November 12, through November 18, 2023;
3 and

4 WHEREAS, The City and County of San Francisco encourages residents, businesses,
5 and community organizations to actively participate in United Against Hate Week by
6 organizing and attending events that promote unity and understanding; and

7 WHEREAS, The City and County of San Francisco reaffirms its dedication to the
8 principles of diversity, inclusion, and respect for all, and condemns all forms of hate and
9 discrimination; and

10 RESOLVED, The Clerk for the Board of Supervisor shall transmit copies of the
11 Resolution to the organizers of United Against Hate Week.
