

1 [Noel and Josephine Ridual and Maria Marquicias]
2 EXPRESSING SYMPATHY AND CONCERN FOR JESSICA RIDUAL UPON THE DEATH OF
3 HER PARENTS, NOEL AND JOSEPHINE RIDUAL, EXTENDING CONDOLENCES TO THE
4 FAMILIES OF MARIA "OLA" MARQUICIAS AND NOEL AND JOSEPHINE RIDUAL AND
5 SUPPORTING THE CREATION OF A TRUST FUND FOR JESSICA RIDUAL BY SAN
6 FRANCISCO GENERAL HOSPITAL.

7 WHEREAS, On October 10, 1999, Noel and Josephine Ridual and
8 Maria "Ola" Marquicias were tragically killed by Lorenzo "Sol" Silva,
9 who then turned the gun upon himself; and

10 WHEREAS, Two-year old Jessica Ridual, who was orphaned by the
11 shooting, was struck by a bullet during the shooting and is currently
12 recovering at San Francisco General Hospital; and,

13 WHEREAS, Noel Ridual and Maria "Ola" Marquicias were among 13
14 Filipino teachers who were recruited in the summer of 1998 to teach
15 in San Francisco public schools; and,

16 WHEREAS, Noel Ridual was a well-respected and popular teacher of
17 mathematics at Lincoln High School; and

18 WHEREAS, Maria "Ola" Marquicias taught special education to
19 severely impaired students at Balboa High School; and,

20 WHEREAS, Josephine Ridual emigrated from the Philippines with
21 her daughter Jessica to join her husband Noel Ridual in 1999; and,

22 WHEREAS, San Francisco is deeply saddened by the loss of life to
23 these two teachers and to the wife of one of the teachers; now,
24 therefore, be it

2 of San Francisco expresses sympathy and concern for Jessica Ridual
3 upon the death of her parents, Noel and Josephine Ridual; and be it

6 Noel and Josephine Ridual and Maria "Ola" Marquicias; and be it,

9 Jessica Ridual by San Francisco General Hospital.




