3 Ordinance authorizing settlement of the lawsuit filed by Yvonne Marie Ellis against the
4 City and County of San Francisco for \$33,000; the lawsuit was filed on June 6, 2018, in
5 San Francisco Superior Court, Case No. CGC-18-567012; entitled Yvonne Marie Ellis v.
6 City and County of San Francisco, et al.; the lawsuit involves an alleged personal injury
7 on a City street.

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Yvonne Marie Ellis v. City and County
12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-18-567012 by the
13 payment of \$33,000. The lawsuit involves an alleged personal injury on a City street.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 June 6, 2018, and the following parties were named in the lawsuit: Yvonne Marie Ellis,
16 plaintiff; City and County of San Francisco, defendants.




