The lawsuit involves PGE's failure to defend and indemnify the City for homeowner damages claims arising from a landslide on Casitas Avenue in San Francisco caused by a PGE construction project.

Section 2. The City filed the Action in San Francisco Superior Court on October 18, 2017, naming PGE as the defendant.
