

## Update to June <sup>2</sup>~~6~~, 2016 GAO Meeting




As of today OSB has confirmed receipt of 79 Board of Supervisor nominations.

- 26 nominees have submitted applications
- 53 have not submitted applications



Of the 26 applications received:

- 18 deemed complete and ready for HPC submission
  - 8 submitted to HPC for July 20, 2016
  - 10 to be submitted to HPC on 7/8/2016 for August 3, 2016
  - 5 to be submitted to HPC on August 22, 2016
- 3 need additional information and each applicant has been informed of what is needed



68 of the total 79 nominees informed of the application instructions and requirements. Outreach continues to nominated businesses.



## **Legacy Business Registry Application Hearings at the Small Business Commission:**

- August 8, 2016: Final hearing for the applications reviewed at the July 20, 2016 HPC meeting
- August 22, 2016: Final hearing for the applications reviewed at the August 3, 2016 HPC meeting
- September 12: Final hearing for the applications reviewed at the August 17, 2016 meeting



## Priorities for the Legacy Business Registry (LBR)

- September 26, 2016: The current 26 applications that have been submitted to date (complete will have received their final hearing before the Small Business Commission).
- Early November: Branding Program Launched.
- OEWD will codify a list of non-profits who will assist small business with crafting their historical narrative's.
- Once OEWD has the final list, Legacy team to train nonprofits on shaping a narrative.
- Legacy Business Program Manager will provide monthly updates to the Board of Supervisors on status of nominees.



## Next Steps for the Historical Preservation Fund

- July 25, 2016: Public Hearing at Small Business Commission for the Business Assistance Grant Program and Rent Stabilization Grant Program administrative and grant guidelines.
- July 27, 2016: Program Guidelines submitted to the Board of Supervisor for 30 day review.
- Extend the Business Assistance Grant filing date three months via Ordinance.
