1 [Settlement Of Lawsuit - Pacific Gas & Electric Company - City To Receive \$6,750,000]

3 **Ordinance authorizing settlement of the lawsuit filed by the City and County of San**
4 **Francisco against Pacific Gas & Electric Company (“PGE”) for \$6,750,000; the lawsuit**
5 **was filed on October 18, 2017, in San Francisco Superior Case No. CGC-17-561957;**
6 **entitled City and County of San Francisco v. Pacific Gas and Electric Company, et al.;**
7 **the lawsuit involves PGE’s failure to defend and indemnify the City for homeowner**
8 **damages claims arising from a landslide on Casitas Avenue in San Francisco caused**
9 **by a PGE construction project; other material terms are that PGE will perform trench**
10 **repairs to prevent further damage and dismissal of the Action with prejudice.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
14 authorizes the City Attorney to settle the action entitled City and County of San Francisco v.
15 Pacific Gas and Electric Company, et al., San Francisco Superior Court Case No.
16 CGC-17-561957 (“Action”), by payment \$6,750,000 by PGE, plus trench repairs by PGE on
17 Casitas Avenue in San Francisco, and dismissal of the Action with prejudice. The lawsuit
18 involves PGE’s failure to defend and indemnify the City for homeowner damages claims
19 arising from a landslide on Casitas Avenue in San Francisco caused by a PGE construction
20 project.

21 Section 2. The City filed the Action in San Francisco Superior Court on
22 October 18, 2017, naming PGE as the defendant.
