3 **Resolution authorizing the San Francisco Department of Public Health to accept and**
4 **expend retroactively a grant in the amount of \$108,600 from the San Francisco**
5 **Community Clinic Consortium, to assist with a project entitled "Homeless Health and**
6 **Wellness Training" for the period of March 27, 2009, through March 26, 2011.**

8 WHEREAS, The San Francisco Community Clinic Consortium is the recipient of a
9 grant award from the Department of Health and Human Services (DHHS) and Health
10 Resources and Services Administration (HRSA) to fund a two-year project entitled "Homeless
11 Health and Wellness Training;" and,

12 WHEREAS, Through this grant, San Francisco Community Clinic Consortium has
13 agreed to fund DPH in the amount of \$108,600 for the period of March 27, 2009 through
14 March 26, 2011; and,

15 WHEREAS, This award is issued under the American Recovery and Reinvestment Act
16 (ARRA) of 2009; and,

17 WHEREAS, As a condition of receiving the grant funds, the San Francisco Community
18 Clinic Consortium requires the City to enter into an agreement (the "Agreement"), a copy of
19 which is on file with the Clerk of the Board of Supervisors in File No. 100207; which is hereby
20 declared to be a part of this resolution as if set forth fully herein; and,

21 WHEREAS, DPH will subcontract with the San Francisco Community Clinic
22 Consortium, in the amount of \$18,000 for the period of March 27, 2009 through March 26,
23 2011 to provide for the AmeriCorps Intern Program; and,

1 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH
2 for one existing position, Public Health Nurse (Job Class #2830) at 0.30 FTE, for the period
3 March 27, 2009 through, March 26, 2011; and,

4 WHEREAS, A request for retroactive approval is being sought because the DPH did
5 not receive a finalized budget until December 9, 2009; and,

6 WHEREAS, The budget does not include a provision for indirect costs because indirect
7 costs are not allowed by the funding agency; now therefore, be it

8 RESOLVED, That DPH is hereby authorized to accept and expend a grant in the
9 amount of \$108,600 from the San Francisco Community Clinic Consortium; and, be it


10 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
11 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,
12 be it

13 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
14 indirect costs in the grant budget; and be it


15 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
16 agreement on behalf of the City; and, be it

17 FURTHER RESOLVED, That the Controller is directed to designate all positions
18 funded under this agreement as "G" or grant-funded positions which would terminate when
19 the agreement expires.


