14 local and state governments for over 30 years; and

18 American Stroke Association; Success Center San Francisco, (formerly known as Youth  
19 Guidance Center Improvement Committee YGIC); SEIU Local 1021 West Bay Retiree  
20 Chapter, SF; and

21 WHEREAS, Beatrice Cardenas-Duncan successfully advocated on behalf of vulnerable  
22 communities including youth of color experiencing the greatest health disparities; and

23 WHEREAS, Beatrice Cardenas-Duncan, through her welcoming spirit, integrity,




