16 jurisdictions to prepare for and respond to terrorist attacks using weapons of mass destruction
17 and provides for the dispersal of federal funds provided for this purpose under Public law 107-
18 206; and,

19 WHEREAS, The City and County of San Francisco has participated in these programs
20 since their inception and deems participation in these programs as vital to the continued well
21 being of its citizens; and,

22 WHEREAS, The State of California requires that applicant's agents be named in the
23 resolution, now, therefore, be it

24 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
25 authorizes the Executive Director of the Department of Emergency Management, or in his or

1 her absence, the Chief Financial Officer of the Department of Emergency Management, or the
2 Deputy Director of the Division of Emergency Services, or the Chief Financial Officer of the
3 Division of Emergency Services, or the Controller of the City and County of San Francisco to
4 execute for and on behalf of the City and County of San Francisco, a public entity established
5 under the laws of the State of California, any applications necessary for the purpose of
6 obtaining federal financial assistance provided by the federal Department of Homeland
7 Security and sub-granted through the State of California under the FY 07 State Homeland
8 Security Program (SHSP) grant, the FY 07 Urban Areas Security Initiative (UASI) grant, the
9 FY 07 Law Enforcement Terrorism Prevention Program (LETPP) grant, the FY 07
10 Metropolitan Medical Response System (MMRS) grant, the FY 07 Citizen Corps Program
