3 \$33,497,367.]

4 **Resolution approving Modification No. 8, the Close-out Modification, of Professional**  
5 **Services Agreement for Contract No. 5700CM – Construction Management Services for**  
6 **the AirTrain System with PGH Wong Engineering/Luster Construction Management, in**  
7 **the amount of \$650,000, for a new total contract amount of \$33,497,367.**

9 WHEREAS, By Resolution No. 95-0116, the Airport Commission awarded a  
10 Professional Services Contract (Contract 5700CM) to PGH Wong Engineering/Luster  
11 Construction Management, to provide construction management services for the Airport's  
12 AirTrain System; and,

13 WHEREAS, By various resolutions, the Airport Commission approved modifications to  
14 the Professional Services Contract for a total current contract value of \$32,847,367 to provide  
15 continuing construction management services for the AirTrain System and CM support for the  
16 Airport's oversight of its' contribution to the BART systems-related costs of the BART-SFO  
17 Extension Project; and,

18 WHEREAS, On June 3, 2003, the Airport Commission approved Modification No. 8 to  
19 the Professional Services Contract with PGH Wong Engineering/Luster Construction  
20 Management, in the amount of \$650,000 for a new total contract amount of \$33,497,367. A  
21 copy is on file with the Clerk of the Board of Supervisors in File No. 031122, which is hereby  
22 declared to be a part of this resolution as if set forth fully herein; and,

23 WHEREAS, In accordance with City Attorney Opinion No. 2002-03/Application of  
24 Charter Section 9.118(b), whereby all contracts in excess of \$10 million or that have a term of  
25 10 years or more, except for construction contracts, are subject to the approval by the Board

1 of Supervisors; now, therefore, be it

2 RESOLVED, That this Board of Supervisors hereby approves Modification No. 8 to the  
3 Professional Services Contract with PGH Wong Engineering/Luster Construction  
4 Management in the amount of \$650,000 for a new total contract amount of \$33,497,367.


