14 the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that
15 the transfer of a Type 20 off-sale general alcoholic beverage control license to Tristan Hoagland for The Gifted
16 Basket, located at 1162 Folsom Street, will serve the convenience of the people of the City and County of San
17 Francisco.

18 Condition: That the sale of beer and/or wine be in conjunction with the sale of gift baskets.




