3 **Ordinance authorizing settlement of the portion of the lawsuit filed by Jane Martin and**
4 **David Baker against the City and County of San Francisco for \$50,000; the lawsuit was**
5 **filed on January 31, 2005, in San Francisco Superior Court, Case No. 436930; entitled**
6 **Jane Martin, et al. v. City and County of San Francisco, et al.**

7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. The City Attorney is hereby authorized to settle the portion of the action
9 entitled "Jane Martin, et al. v. City and County of San Francisco, et al." San Francisco
10 Superior Court, Court No. 436930, as it relates only to co-plaintiffs Jane Martin and David
11 Baker, by the payment of \$50,000, representing the claim for diminution of property value, and
12 excluding attorney's fees, costs and interest, which will be addressed in later proceedings.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiffs Jane
15 Martin and David Baker and Defendant City and County of San Francisco.
