2 Friends and Foundation of the San Francisco Public Library to support public programming
and community outreach activities for the Library system.]

4 **Resolution authorizing the San Francisco Public Library to accept and expend a gift in**
5 **the amount of \$44,342 from the Friends and Foundation of the San Francisco Public**
6 **Library to support public programming and outreach at Branch Libraries and to**
7 **continue production of a monthly newsletter to promote programs, services and**
8 **special events offered by the Public Library.**

10 WHEREAS, The San Francisco Public Library provides quality programs, services, and
11 special events and exhibits for the residents of the City; and

12 WHEREAS, The San Francisco Public Library seeks to actively promote the services,
13 programs, and special events it offers the diverse communities and neighborhoods it serves;
14 and,

15 WHEREAS, The San Francisco Public Library is continually seeking ways to expand
16 community participation in the programs and services it offers; and,

17 WHEREAS, The Friends and Foundation of the San Francisco Public Library is a non-
18 profit organization that seeks to provide support for the Public Library by providing resources
19 to accomplish Library goals; and,

20 WHEREAS, The San Francisco Public Library has requested, and the Friends and
21 Foundation of the Public Library have agreed to provide \$22,189 for a half-time Curator II to
22 conduct outreach activities to neighborhoods and communities served by Branch Libraries
23 thereby increasing community awareness and participation in programs offered by the Library;

1 WHEREAS, The San Francisco Public Library has requested and the Friends and
2 Foundation of the Public Library have agreed to provide \$22,153 for a half-time Public
3 Relations Officer to write, edit, and manage the production of "At the Public Library" a monthly
4 publication that promotes Library services, programs, and special exhibits and programs for
5 children, youth, and adults; and, provides information on Library locations, hours, and general
6 items of interest; and,

7 WHEREAS, The San Francisco Public Library proposes to maximize use of available
8 gift funds by not including indirect costs in the gift budget; now, therefore, be it

9 RESOLVED, That the San Francisco Public Library be authorized to accept and
10 expend a gift of \$44,342 from the Friends and Foundation of the San Francisco Public Library
11 and to establish limited-term positions to conduct outreach activities geared to the
12 neighborhood communities served by the Library and to continue the publication of "At the
13 Public Library".
