2 APPROVING REVISED SCHEDULE OF SERVICE FEES TO BE CHARGED BY THE SAN  
3 FRANCISCO PUBLIC UTILITIES COMMISSION TO RETAIL WATER CUSTOMERS IN SAN  
4 FRANCISCO AND SUBURBAN AREAS

6 Be it ordained by the People of the City and County of San Francisco:

7 Section 1. The Public Utilities Commission adopted on April 27, 1999 its Resolution  
8 No. 99-0109 after having held a public hearing on April 27, 1999 to consider a proposal for an  
9 adjustment of certain service fees charged to retail water customers in San Francisco and  
10 suburban areas. Members of the public have been given an opportunity to express their  
11 views on the recommended Schedule of Fees. Pursuant to a published notice of intention of  
12 the Public Utilities Commission to adopt a revised Schedule of Fees to be charged to retail  
13 water customers in San Francisco and suburban areas, and a public hearing having been  
14 held on April 27, 1999, a copy of said Schedules W-43 and W-44 being on file with the  
15 Secretary of the Commission, the Commission recommended the revised Schedule of Fees  
16 enumerated in Schedules W-43 and W-44.

17 Section 2. The foregoing rate schedule is for the purpose of meeting operating  
18 expenses, including employee wage rate and fringe benefits, purchasing or leasing supplies,  
19 equipment or materials, meeting financial reserve needs and requirements and obtaining  
20 funds for capital projects necessary to maintain service within the existing service areas and  
21 other budgetary requirements of the Public Utilities Commission's water service enterprise.

22 Section 3. The Public Utilities Commission, in accordance with Administrative Code  
23 2.25 – 2.29, recommended the revised Schedule of Fees based upon the water service  
24 enterprise budget for the current and ensuing fiscal year, and all the data supporting such  
25 conclusions. The Public Utilities Commission has submitted to this Board in support of said

1 Schedule all of the data upon which it is based for the current fiscal year (1998-1999) and the  
2 ensuing fiscal year (1999-2000).

3 Section 4. This Board of Supervisors hereby finds that said Schedule together with  
4 other Schedules of Rates of the water service enterprise will provide revenues adequate to  
5 fund the 1999-2000 departmental budget and will be sufficient to pay for the balance of the  
6 current fiscal year and the ensuing fiscal year all expenses of every kind and nature incidental  
7 to the operation and maintenance of the San Francisco water service enterprise, together with  
8 interest and sinking fund charges for any bonds issued for the acquisition, construction or  
9 extension of the San Francisco water service enterprise without tax subsidy.

10 Section 5. The Certificate of Determination of Exemption/Exclusion From  
11 Environmental Review on file in Board of Supervisors File No. 990918 states that  
12 the adoption of the schedule, as stated herein, is exempt from environmental review  
13 requirements in accordance with California Public Resources Code Section 21080(b)(8).

15 Section 6. FY 1999-2000 Schedules W-43 and W-44, as recommended by the Public  
16 Utilities Commission and on file with the Clerk of the Board of Supervisors shall be effective  
17 as of July 1, 1999.




