WHEREAS, Under Title I of the Housing and Community Development Act of 1974, as amended, and related federal regulations, the City and County of San Francisco is eligible to apply for and receive Community Development Block Grant (CDBG) funding from the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, The City and County of San Francisco anticipates receiving approximately \$21,500,000 in CDBG Program Funds from HUD in 2009-10; and,

WHEREAS, on behalf of the City and County of San Francisco, the Mayor's Office of Community Investment (MOCI) is preparing to release a Request for Proposals (RFP) for the 2009-10 CDBG Program; and,

WHEREAS, the RFP is in concert with the MOCI Consolidated Plan for program years 2005-2009; and,

WHEREAS, the Consolidated Plan was approved by HUD in 2005, and will be updated to plan for 2010-2014; and,

WHEREAS, the Consolidated Plan details the Mayor's Office of Community Investment and the Mayor's Office of Housing seven goals for the CDBG Program: 1) Promote economic self-sufficiency for low and moderate income families; 2) Strengthen neighborhood vitality; 3) Increase the provision of timely, relevant and effective social services; 4) Promote equity-based public policy strategies; 5) Create housing opportunities for the homeless; 6) Create affordable rental housing for individuals and families with incomes up to 60% of San Francisco median income; and 7) Create homeownership opportunities for individuals and families up to

100% of San Francisco median income, and support existing homeownership programs including funding housing counseling agencies to advise eligible San Franciscans of existing homeownership programs, for families up to 120% of median income; now, therefore, be it

RESOLVED, That the Board of Supervisors continues to support the seven CDBG Consolidated Plan goals, and the related 2009-2010 Request for Proposals to achieve these goals.
