6 WHEREAS, California Government Code, Section 56325, provides that a Local Agency  
7 Formation Commission shall consist of either four members of the Board of Supervisors, or  
8 three members of the Board of Supervisors and the Mayor. All four members, and one  
9 alternate member, of the San Francisco Local Agency Formation Commission are appointed  
10 by the Board of Supervisors. These four members select one public member and one  
11 alternate public member; now, therefore, be it

12 MOVED, That the Board of Supervisors of the City and County of San Francisco does  
13 hereby appoint the hereinafter designated person to serve as a member of the San Francisco  
14 Local Agency Formation Commission, pursuant to the provisions of California Government  
15 Code, Section 56325, for the term specified:

16 Supervisor Hillary Ronen, seat 1, succeeding London Breed, resigned, must be a City  
17 Officer, which means the Mayor or a member of the legislative body appointed by the Board of  
18 Supervisors, for the unexpired portion of a four-year term ending February 4, 2019.


