3 **Ordinance amending the Article 6 of the Park Code by adding Section 6.14 to authorize**  
4 **the San Francisco Municipal Transportation Agency to identify areas located on**  
5 **property under the jurisdiction of the Recreation and Park Commission that are**  
6 **suitable for paid parking; to set rates for such parking; and to develop and implement a**  
7 **parking management plan for park property, and making environmental findings.**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Findings. The Planning Department has determined that the actions  
13 contemplated in this Ordinance are in compliance with the California Environmental Quality  
14 Act (California Public Resources Code sections 21000 et. seq.). Said determination is on file  
15 with the Clerk of the Board of Supervisors in File No. 090716 and is incorporated  
16 herein by reference.

17 Section 2. The San Francisco Park Code is hereby amended by adding Section 6.14,  
18 to read as follows:

19 **SEC. 6.14. Authorization of the San Francisco Municipal Transportation Agency.**

20 (a) The San Francisco Municipal Transportation Agency (SFMTA) is authorized, in  
21 conformance with Charter Article VIII A, to work with Recreation and Park Department staff to:

22 (1) identify locations suitable for the establishment of paid parking areas or zones on property  
23 under the jurisdiction of the Recreation and Park Commission, including, but not limited to, the use of  
24 pay stations and parking permits;

1           (2) set rates for paid parking on park property that are closely comparable to the rates set for  
2 similarly situated paid parking;

3           (3) develop and implement a parking management plan for park property;

4           (b) The implementation of any parking restrictions, parking rates and/or parking management  
5 plan by the SFMTA under this section shall be subject to the approval of the Commission; the location  
6 of paid parking areas and parking restrictions are subject to the approval of the Board of  
7 Supervisors.

8           (c) The Commission shall retain authority to grant or deny permits for the use or closure of  
9 park roads in conformance with S.F. Municipal Code and Commission policies.


