10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Yun Wan Pang v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-20-585148 by the
13 payment of \$200,000. The lawsuit involves alleged personal injury on a City sidewalk.
