FURTHER RESOLVED, That the Department of Public Health, San Francisco General Hospital is hereby authorized to accept and expend a gift estimated to be approximately \$25,000 bequeathed to San Francisco General Hospital from the estate of Beatrice Druhe to be used for the general benefit of all patients at San Francisco General Hospital.


