10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby

12 San Francisco, United States District Court, Northern District of California, Case No. 3:21-cv-
13 02934-SI by the payment of \$116,250. The lawsuit involves an employment dispute.
