Section 2. POWERS: The Commission shall have the power to:

- (a) Hold Hearings and submit recommendations to the Board of Supervisors and the Mayor regarding the problems, interests, and needs of veterans;
- (b) Make recommendations to the Board of Supervisors and the Mayor concerning the coordination of economic development, health care, and social service programs as they relate to veterans who are resic of San Francisco.
