8 **Francisco, et al.; the lawsuit involves alleged personal injury from pedestrians being**
9 **struck by a City vehicle.**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
13 authorizes the City Attorney to settle the action entitled Gail Bonnifield, et al. v. City and
14 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-17-557677 by
15 the payment of \$110,000. The lawsuit involves alleged personal injury from pedestrians being
16 struck by a City vehicle.

17 Section 2. The above-named action was filed in San Francisco Superior Court on
18 March 22, 2017, and the following parties were named in the lawsuit: plaintiffs: Gail
19 Bonnifield, Aquene Cali Montano, a Minor, By And Through Her Guardian Ad Litem Ulises
20 Montano, and Dontanayia Lockwood; defendants: City and County of San Francisco and




