3 **Ordinance authorizing a partial settlement of the lawsuit filed by Aidan Gauper and**
4 **Cory Maryott against the City and County of San Francisco for \$800,000; the lawsuit**
5 **was filed on April 10, 2023, in San Francisco Superior Court, Case No. CGC-23-605730;**
6 **entitled Ralph Bower, et al. v. City and County of San Francisco; the lawsuit involves**
7 **alleged personal injury on a City street.**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes
10 the City Attorney to settle the action entitled Ralph Bower, et al. v. City and County of San
11 Francisco, San Francisco Superior Court, Case No. CGC-23-605730 by the payment of
12 \$800,000. The lawsuit involves alleged personal injury on a City street.

13 Section 2. The above-named action was filed in San Francisco Superior Court on April
14 10, 2023, and the following parties were named in the lawsuit: Plaintiffs Ralph Bower,
15 Veronica Fulton, Aidan Gauper and Cory Maryott; Defendant City and County of San
16 Francisco. This is a partial settlement of the case involving Plaintiffs Aidan Gauper and Cory
17 Maryott only.
