9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Valerie A. Stevenson v. City and
12 County of San Francisco, San Francisco Superior Court, Case No. CGC-20-585157 by the
13 payment of \$75,000. The lawsuit involves an alleged trip and fall on uneven pavement.

14 Section 2. The above-named action was filed in San Francisco Superior Court on July
15 1, 2020, and the following parties were named in the lawsuit: Plaintiff: Valerie A. Stevenson,
