22 to a Type 21 off-sale general alcoholic beverage control license from Safeway Store  
23 Unit 203 located at 2300 – 16<sup>th</sup> Street to Safeway Store #4601 at 145 Jackson Street  
24 (District 3) will serve the public convenience and necessity of the people of the City and  
25 County of San Francisco.




