7 WHEREAS, JNJ Roof Prop has gifted the Fire Department with a roof training prop
8 valued at \$24,417; and

9 WHEREAS, JNJ Roof Prop used knowledge and input from active firefighters to design
10 a roof prop to allow departments to conduct realistic training scenarios in safe and controlled
11 environments; and

12 WHEREAS, This roof assists with providing members a simulation of cutting ventilation
13 holes in a roof that are not easily duplicated in a training environment; and

14 WHEREAS, The Fire Department's intent for the use of this prop would be to provide
15 additional tools for its Division of Training to improve hands-on training for its members; and

16 WHEREAS, At its regular meeting on Wednesday, August 8th, 2018, the Fire
17 Commission voted to recommend that the Board of Supervisors approve the gift and
18 authorize the Chief of the Fire Department to accept the donation to the Department; and

19 WHEREAS, The Fire Commission Resolution is on file with the Clerk of the Board of
20 Supervisors in File No. 190171, which is hereby declared to be a part of this resolution as if
21 set forth fully herein; now, therefore, be it


22 RESOLVED, That the Board of Supervisors approves the donation and authorize the

3 the Fire Department and public safety.




