3 **Resolution designating certain intersections as "STOP" intersections.**

4 RESOLVED, That, pursuant to the provisions of the California Vehicle Code, the  
5 following intersections are hereby designated as "STOP" intersections, and the  
6 Department of Parking and Traffic is hereby authorized and directed to cause "STOP"  
7 signs to be installed thereat as designated below:

8 **STOP SIGNS – ESTABLISH**

9 Westgate Drive and Darien Way, installing STOP signs at this intersection,  
10 making this intersection an All-Way STOP;

11 Newhall Street and Quesada Avenue, stopping Newhall Street at Quesada  
12 Avenue, making this intersection an All-Way STOP;

13 ~~4<sup>th</sup> Avenue and Clement Street, stopping Clement Street at 4<sup>th</sup> Avenue, making  
14 intersection an All-Way STOP;~~

15 Wisconsin and 22<sup>nd</sup> Streets, stopping Wisconsin at 22<sup>nd</sup> Street making this  
16 intersection an All-Way STOP;

17 Bacon and Hamilton Streets, stopping Bacon Street, making this intersection an  
18 All-Way STOP;

19 Somerset Street and San Bruno Avenue, stopping Somerset Street at San Bruno  
20 Avenue, the stem of this Y-intersection;

21 Octavia Frontage Road, stopping southbound Octavia Frontage Road at  
22 Market Street;

23 Octavia Frontage Road, stopping northbound Octavia Frontage Road at  
24 Hayes Street;

25 Ingalls Street at Armstrong Street, making intersection All-Way STOP;

Jennings Street at Wallace Street, making intersection All-Way STOP;

Hoff Street at 16th and 17th Streets, stopping the stem of these T-intersections.




