3 **Ordinance authorizing settlement of the lawsuit filed by Michael Petersen against the**
4 **City and County of San Francisco for \$75,000; the lawsuit was filed on September 12,**
5 **2019, in San Francisco Superior Court, Case No. CGC-19-579234; entitled Michael**
6 **Petersen v. City and County of San Francisco; the lawsuit involves alleged personal**
7 **injury in a City park.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Michael Petersen v. City and County
12 of San Francisco, San Francisco Superior Court, Case No. CGC-19-579234 by the payment
13 of \$75,000. The lawsuit involves alleged personal injury in a City park.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 September 12, 2019, and the following parties were named in the lawsuit: Michael Petersen,
16 Plaintiff; City and County of San Francisco, Defendant.
