

1 [Airport Emergency Contract - Covenant Aviation Security, LLC - General Airport Security
2 Services - Not to Exceed \$1,700,000]

3 **Resolution retroactively approving Emergency Contract No. 50177 for General Airport**
4 **Security Services between Covenant Aviation Security, LLC, and the City and County**
5 **of San Francisco, acting by and through its Airport Commission, in an amount not to**
6 **exceed \$1,700,000 over a six month term from April 9, 2018, through October 8, 2018.**

8 WHEREAS, The Airport's general security services contractor defaulted, and the
9 Airport issued a notice of termination of that contract, effective Monday, April 9, 2018, at 2300
10 hours; and

11 WHEREAS, On April 6, 2018, the Airport Commission declared an emergency; and

12 WHEREAS, On April 24, 2018, by Resolution No. 18-0111, the Airport Commission
13 awarded the Emergency Contract to Covenant Aviation Security, LLC for Transportation
14 Security Administration (TSA)-Approved Airport Security Program (ASP) requirement for
15 Airports to conduct inspections of all deliveries, merchandise, consumables, and employees
16 accessing the Sterile Area (post security) from the Secured Areas; and

17 WHEREAS, As security is critical to safeguard the Airport, the traveling public, and the
18 thousands of people who work at San Francisco International Airport, we must maintain
19 continuous general security services with minimal interruption; the Airport contacted Covenant
20 Aviation Security, LLC, who was the second ranked proposer in the most recent Request for
21 Proposals for General Airport Security Services, to take over the service immediately upon the
22 departure of the defaulting contractor; and

23 WHEREAS, The Airport and Covenant Aviation Security, LLC, have successfully
24 concluded negotiations and reached agreement on the contract terms and conditions; and

1 WHEREAS, Copies of the Contract are on file with the Clerk of the Board of
2 Supervisors in File No. 180494; now, therefore, be it

3 RESOLVED, That the Board of Supervisors hereby approves the Emergency Contract
4 No. 50177 for General Airport Security Services between Covenant Aviation Security, LLC
5 and the City and County of San Francisco, acting by and through its Airport Commission, in
6 an amount not to exceed \$1,700,000 over a six month term from April 9, 2018, through
7 October 8, 2018; and, be it

8 FURTHER RESOLVED, That within thirty (30) days of the Contract being fully
9 executed by all parties, the Airport Commission shall provide the executed Contract to the
10 Clerk of the Board for inclusion into the official file.
