20 ~~allowable rent during the five-year period after an OMI is guilty of a misdemeanor;~~
21 ~~require the Rent Board to annually notify the unit occupant of the maximum rent for the~~
22 ~~unit for five three years after an OMI or RMI, and authorize the occupant to sue for three~~
23 ~~times any excess rent charged; and extend the statute of limitations for wrongful~~
24 ~~eviction claims based on an unlawful OMI or RMI from one year to five three years; and~~

Be it ordained by the People of the City and County of San Francisco:

Section 1. The Administrative Code is hereby amended by revising Sections 37.6, 37.9, ~~and 37.9B~~, 37.10A, and 37.11A, to read as follows:

SEC. 37.6. POWERS AND DUTIES.

In addition to other powers and duties set forth in this Chapter, and in addition to powers under the Charter and under other City Codes, including powers and duties under Administrative Code Chapter 49 ("Interest Rates on Security Deposits"), the Rent Board shall have the power to:

* * * *

(k) ~~Compile a list at random, on~~On a monthly basis starting January 1, 2018, compile copies at random of 10% percent of the all statements of occupancy filed with the Rent Board pursuant to Section 37.9(a)(8)(vii), and compile a list of all units for which the required statement of occupancy was not filed with the Rent Board~~notices to vacate filed pursuant to Section 37.9(c) which state on the notice or in any additional written document any causes under Section 37.9(a)(8) as the reason for eviction.~~ Said copies and said list shall be transmitted to the District Attorney on a monthly basis for investigation pursuant to Section 37.9(e). In cases where the District Attorney determines that Section 37.9(a)(8) has been

1 violated, the District Attorney shall take whatever action he or she deems appropriate under
2 this Chapter 37 or under State law.

5 **SEC. 37.9. EVICTIONS.**

6 Notwithstanding Section 37.3, this Section 37.9 shall apply as of August 24, 1980, to all
7 landlords and tenants of rental units as defined in Section 37.2(r).

8 (a) A landlord shall not endeavor to recover possession of a rental unit unless:

9 * * * *

10 (8) The landlord seeks to recover possession in good faith, without ulterior reasons
11 and with honest intent:

12 (i) For the landlord's use or occupancy as his or her principal residence for a
13 period of at least 36 continuous months;

14 (ii) For the use or occupancy of the landlord's grandparents, grandchildren,
15 parents, children, brother or sister, or the landlord's spouse, or the spouses of such relations,
16 as their principal place of residency for a period of at least 36 months, in the same building in
17 which the landlord resides as his or her principal place of residency, or in a building in which
18 the landlord is simultaneously seeking possession of a rental unit under Section 37.9(a)(8)(i).
19 For purposes of this Section 37.9(a)(8)(ii), the term "spouse" shall include domestic partners
20 as defined in ~~San Francisco~~ Administrative Code Sections 62.1 through 62.8.

21 * * * *

22 (v) Commencing January 1, 2018, the landlord shall attach to the ~~The~~ notice to
23 vacate shall include a form prepared by the Rent Board that the tenant can use to keep the Rent Board
24 apprised of any future change in address, and shall include in the notice a declaration executed by
25 the landlord under penalty of perjury stating that the landlord seeks to recover possession of the unit in

1 good faith, without ulterior reasons and with honest intent, for use or occupancy as the principal
2 residence of the landlord or the landlord's relative (identified by name and relation to the landlord),
3 for a period of at least 36 continuous months, as set forth in subsections 37.9(a)(8)(i) and (ii). The
4 landlord shall file the notice with the Rent Board pursuant to Section 37.9(c). Evidence of any
5 of the following shall create a rebuttable presumption that the landlord has not acted in good faith
6 may include, but is not limited to, any of the following, unless and until evidence is introduced
7 that would support a finding that the landlord has acted in good faith, in which case the trier of
8 fact shall determine the existence or nonexistence of the presumed fact from the evidence
9 and without regard to the presumption: (1) the landlord has failed refused to file the notice to
10 vacate with the Rent Board as required by Section 37.9(c), (2) It shall be rebuttably presumed that
11 the landlord has not acted in good faith if the landlord or relative for whom the tenant was evicted
12 did does not move into the rental unit within three months after the landlord recovered possession
13 and then occupy said unit as that person's principal residence for a minimum of 36
14 consecutive months after moving in, or (3) the landlord or relative for whom the tenant was
15 evicted lacks a legitimate, bona fide reason for not moving into the unit within three months
16 after the recovery of possession and/or then occupying said unit as that person's principal
17 residence for a minimum of 36 consecutive months, (4) the landlord did not file a statement of
18 occupancy with the Rent Board as required by Section 37.9(a)(8)(vii), (5) the landlord violated
19 Section 37.9B by renting the unit to a new tenant at a rent greater than that which would have
20 been the rent had the tenant who had been required to vacate remained in continuous occupancy and
21 the rental unit remained subject to this Chapter 37 as provided in Section 37.9B, and (6) such
22 other factors as a court or the Rent Board may deem relevant. Nothing in this Section
23 37.9(a)(8)(v) is intended to alter or diminish any other right to relief that a tenant may have
24 based on a landlord's failure to comply with this Chapter 37.

25 * * * *

1 (vii) A landlord who has recovered possession of a unit pursuant to Section 37.9(a)(8)
2 on or after January 1, 2018 must complete a statement of occupancy under penalty of perjury on a
3 form to be prepared by the Rent Board that discloses whether the landlord has recovered
4 possession of the unit. The landlord shall file the statement of occupancy with the Rent Board
5 within 90 days after the date of service, and shall file an updated statement of occupancy
6 every 90 days thereafter, unless the statement of occupancy discloses that the landlord is no
7 longer endeavoring to recover possession of the unit, in which case no further statements of
8 occupancy need be filed. If the statement of occupancy discloses that the landlord has
9 already recovered possession of the unit, the landlord shall file updated statements of
10 occupancy once a year for five years, no later than 12 months, 24 months, 36 months, 48
11 months, and 60 months after the recovery of possession of the unit. Each statement of
12 occupancy filed after the landlord has recovered possession of the unit shall disclose the date
13 of recovery of possession, whether the landlord or relative for whom the tenant was evicted is
14 occupying the unit as that person's principal residence with at least two forms of supporting
15 documentation, the date such occupancy commenced (or alternatively, the reasons why
16 occupancy has not yet commenced), the rent charged for the unit if any, and such other
17 information and documentation as the Rent Board may require in order to effectuate the
18 purposes of this Section 37.9(a)(8). The Rent Board shall make all reasonable efforts to send
19 the displaced tenant a copy of each statement of occupancy within 30 days of the date of
20 filing, or a notice that the landlord did not file a statement of occupancy if no statement of
21 occupancy was filed. In addition, the Rent Board shall impose an administrative penalty on
22 any landlord who fails to comply with this subsection (a)(8)(vii), in the amount of \$250 for the
23 first violation, \$500 for the second violation, and \$1,000 for every subsequent violation. The
24 procedure for the imposition, enforcement, collection, and administrative review of the
25 administrative penalty shall be governed by Administrative Code Chapter 100, "Procedures

1 Governing the Imposition of Administrative Fines," which is hereby incorporated in its
2 entirety. ~~The landlord shall file the statement of occupancy with the Rent Board three months~~
3 ~~after recovery of possession of the unit, and shall file updated statements of occupancy 12~~
4 ~~months, 24 months, and 36 months after the recovery of possession of the unit. The~~
5 ~~statement, including the updates, shall identify whether the unit is (1) occupied as the principal~~
6 ~~place of residence of the landlord or the relative (identified by name and relation to the~~
7 ~~landlord) for whom the tenant was evicted, (2) occupied by another person, or (3) unoccupied.~~
8 ~~If the unit is occupied by a person other than the landlord or relative for whom the tenant was~~
9 ~~evicted, the statement of occupancy shall also disclose the current rent for the unit; and the~~
10 ~~Rent Board shall make all reasonable efforts to send the displaced tenant a copy of the~~
11 ~~statement of occupancy within 30 days of the date of filing, or a notice that the landlord did not~~
12 ~~file a statement of occupancy if no statement of occupancy was filed. If the unit is occupied~~
13 ~~by the landlord or the relative for whom the tenant was evicted, the landlord shall also~~
14 ~~simultaneously file with the Rent Board at least two forms of documentation in which the unit~~
15 ~~is listed as the landlord or relative's place of residence. Acceptable forms of this~~
16 ~~documentation shall include at least two of the following categories: (1) current utility services~~
17 ~~contract or utility billing records from within 45 days of the date of filing; (2) current motor~~
18 ~~vehicle registration and insurance policy for the vehicle; (3) current homeowner's or renter's~~
19 ~~insurance policy; (4) correspondence from within 45 days of the date of filing from any~~
20 ~~government agency, including federal, state, and local taxing authorities; (5) current voter~~
21 ~~registration; (6) current driver's license; (7) proof that the individual has obtained a~~
22 ~~homeowner's exemption from property taxes for the unit; or (8) any other credible~~
23 ~~documentary evidence showing that the landlord or relative actually occupies the rental unit~~
24 ~~as his or her principal place of residence. Evidence that the landlord did not timely file a~~
25 ~~statement of occupancy and supporting documentation with the Rent Board shall create a~~

1 ~~rebuttable presumption that the landlord did not recover possession of the unit in good faith,~~
2 ~~unless and until evidence is introduced that would support a finding that the landlord did~~
3 ~~recover possession of the unit in good faith, in which case the trier of fact shall determine the~~
4 ~~existence or nonexistence of the presumed fact from the evidence and without regard to the~~
5 ~~presumption.~~

6 (viii) If any provision or clause of this ~~amendment to~~ Section 37.9(a)(8) or the
7 application thereof to any person or circumstance is held to be unconstitutional or to be
8 otherwise invalid by any court of competent jurisdiction, such invalidity shall not affect other
9 chapter provisions, and clauses of this Chapter are held to be severable; or

11 (c) A landlord shall not endeavor to recover possession of a rental unit unless at
12 least one of the grounds enumerated in Section 37.9(a) or (b) above is (1) the landlord's
13 dominant motive for recovering possession and (2) unless the landlord informs the tenant in
14 writing on or before the date upon which notice to vacate is given of the grounds under which
15 possession is sought, and for notices to vacate under Sections 37.9(a)(8), (9), (10), (11), and
16 (14), state in the notice to vacate the lawful rent for the unit at the time the notice is issued,
17 before endeavoring to recover possession. The Board shall prepare a written form that (1)
18 states that a tenant's failure to timely act in response to a notice to vacate may result in a
19 lawsuit by the landlord to evict the tenant, and that advice regarding the notice to vacate is
20 available from the Board; and (2) includes information provided by the Mayor's Office of
21 Housing and Community Development regarding eligibility for affordable housing programs.
22 The Board shall prepare the form in English, Chinese, Spanish, Vietnamese, Tagalog, and
23 Russian and make the form available to the public on its website and in its office. A landlord
24 shall attach a copy of the form that is in the primary language of the tenant to a notice to
25 vacate before serving the notice, except that if the tenant's primary language is not English,

1 Chinese, Spanish, Vietnamese, Tagalog, or Russian, the landlord shall attach a copy of the
2 form that is in English to the notice. A copy of all notices to vacate except three-day notices to
3 ~~vacate or pay rent or quit~~ and a copy of any additional written documents informing the tenant
4 of the grounds under which possession is sought shall be filed with the Board within 10 days
5 following service of the notice to vacate. ~~The District Attorney shall determine whether the~~
6 ~~units set forth on the list compiled in accordance with Section 37.6(k) are still being occupied~~
7 ~~by the tenant who succeeded the tenant upon whom the notice was served. In cases where~~
8 ~~the District Attorney determines that Section 37.9(a)(8) has been violated, the District Attorney~~
9 ~~shall take whatever action he deems appropriate under this Chapter or under State law. In~~
10 any action to recover possession of the rental unit under Section 37.9, the landlord must plead
11 and prove that at least one of the grounds enumerated in Section 37.9(a) or (b) and also
12 stated in the notice to vacate is the dominant motive for recovering possession. Tenants may
13 rebut the allegation that any of the grounds stated in the notice to vacate is the dominant
14 motive.

16 (f) Whenever a landlord wrongfully endeavors to recover possession or recovers
17 possession of a rental unit in violation of Sections 37.9 and/or 37.10A as enacted herein, the
18 tenant or Rent Board may institute a civil proceeding for injunctive relief, money damages of
19 not less than three times actual damages, (including damages for mental or emotional
20 distress as specified below), and whatever other relief the court deems appropriate. If the
21 landlord has recovered possession pursuant to Section 37.9(a)(8), such action shall be brought no later
22 than five three years after (1) the date the landlord files the first statement of occupancy with the
23 Rent Board under Section 37.9(a)(8)(vii) or (2) three months after the landlord recovers
24 possession, whichever is earlier of recovery of possession. In the case of an award of
25 damages for mental or emotional distress, said award shall only be trebled if the trier of fact

1 finds that the landlord acted in knowing violation of or in reckless disregard of Section 37.9 or
2 37.10A herein. The prevailing party shall be entitled to reasonable attorney's fees and costs
3 pursuant to order of the court. The remedy available under this Section 37.9(f) shall be in
4 addition to any other existing remedies which may be available to the tenant or the Rent
5 Board.

8 **SEC. 37.9B. TENANT RIGHTS IN EVICTIONS UNDER SECTION 37.9(a)(8).**

9 (a) Any rental unit which a tenant vacates after receiving a notice to quit based on
10 Section 37.9(a)(8), and which is subsequently no longer occupied as a principal residence by
11 the landlord or the landlord's grandparent, parent, child, grandchild, brother, sister, or the
12 landlord's spouse, or the spouses of such relations must, if offered for rent during the five-
13 ~~three-~~year period following service of the notice to quit under Section 37.9(a)(8), be rented in
14 good faith at a rent not greater than that which would have been the rent had the tenant who
15 had been required to vacate remained in continuous occupancy and the rental unit remained
16 subject to this Chapter 37. If it is asserted that a rent increase could have taken place during
17 the occupancy of the rental unit by the landlord if the rental unit had been subjected to this
18 Chapter, the landlord shall bear the burden of proving that the rent could have been legally
19 increased during the period. If it is asserted that the increase is based in whole or in part upon
20 any grounds other than that set forth in Section 37.3(a)(1), the landlord must petition the Rent
21 Board pursuant to the procedures of this Chapter. Displaced tenants shall be entitled to
22 participate in and present evidence at any hearing held on such a petition. Tenants displaced
23 pursuant to Section 37.9(a)(8) shall make all reasonable efforts to keep the Rent Board
24 apprised of their current address. The Rent Board shall provide notice of any proceedings
25 before the Rent Board to the displaced tenant at the last address provided by the tenant. No

1 increase shall be allowed on account of any expense incurred in connection with the
2 displacement of the tenant.

3 (b) (1) For notices to vacate served before January 1, 2018, anyAny landlord who,
4 within three years of the date of service of the notice to quit, offers for rent or lease any unit in
5 which the possession was recovered pursuant to Section 37.9(a)(8) shall first offer the unit for
6 rent or lease to the tenants displaced, in the same manner as provided for in Sections
7 37.9A(c) and (d).

8 (2) For notices to vacate served on or after January 1, 2018, any landlord who,
9 within five years of the date of service of the notice to quit, offers for rent or lease any unit in
10 which the possession was recovered pursuant to Section 37.9(a)(8) shall first offer the unit for
11 rent or lease to the tenants displaced, by mailing a written offer to the address that the tenant
12 has provided to the landlord. If the tenant has not provided the landlord a mailing address,
13 the landlord shall mail the offer to the address on file with the Rent Board, and if the Rent
14 Board does not have an address on file, then to the unit from which the tenant was displaced
15 and to any other physical or electronic address of the tenant of which the landlord has actual
16 knowledge. The landlord shall file a copy of the offer with the Rent Board within 15 days of
17 the offer. The tenant shall have 30 days from receipt of the offer to notify the landlord of
18 acceptance or rejection of the offer and, if accepted, shall reoccupy the unit within 45 days of
19 receipt of the offer.

20 * * * *

21 (e) Within 30 days after the effective date of a written notice to vacate that is filed with
22 the Rent Board under Section 37.9B(c) the Rent Board shall record a notice of constraints with
23 the County Recorder identifying each unit on the property that is the subject of the Section
24 37.9B(c) notice to vacate, stating the nature and dates of applicable restrictions under
25 Sections 37.9(a)(8) and 37.9B. For notices to vacate filed under Section 37.9B(c) on or after

1 January 1, 2018, the~~The~~ Rent Board shall also send a notice to the unit that states the maximum rent
2 for that unit under Sections 37.9(a)(8) and 37.9B, and shall send an updated notice to the unit 12
3 months, 24 months, ~~and 36 months, 48 months, and 60 months~~ thereafter, or within 30 days of such
4 date. If a notice of constraints is recorded but the tenant does not vacate the unit, the landlord
5 may apply to the Rent Board for a rescission of the recorded notice of constraints. The Rent
6 Board shall not be required to send any further notices to the unit pursuant to this subsection (e) if the
7 constraints on the unit are rescinded.

9 **SEC. 37.10A. MISDEMEANORS, AND OTHER ENFORCEMENT PROVISIONS.**

10 * * * *

11 ~~(c)~~ It shall be unlawful for a landlord or for any person who willfully assists a landlord
12 to request that a tenant move from a rental unit or to threaten to recover possession of a
13 rental unit, either verbally or in writing, unless:

14 ~~(1)~~ The landlord in good faith intends to recover said unit under one of the grounds
15 enumerated in Section 37.9(a) or (b); and

16 ~~(2)~~ Within five days of any such request or threat the landlord serves the tenant with
17 a written notice stating the particular ground under Section 37.9(a) or (b) that is the basis for
18 the landlord's intended recovery of possession of the unit.

19 ~~(c)(d)~~ It shall be unlawful for a landlord or for any person who willfully assists a
20 landlord to recover possession of a rental unit unless, prior to recovery of possession of the
21 unit:

22 ~~(1)~~ The landlord files a copy of the written notice required under Section 37.10A(c)
23 with the Board together with any preceding warning or threat to recover possession, unless
24 the particular ground for recovery is non-payment of rent; and

1 ~~(2)~~ ~~The~~ the landlord satisfies all requirements for recovery of the unit under Section
2 37.9(a) or (b).

3 (d)~~(e)~~ In any criminal or civil proceeding based on a violation of Section ~~37.10A(e)~~ or
4 37.10A(c)~~(d)~~, the landlord's failure to use a recovered unit for the Section 37.9(a) or (b)
5 ground stated verbally or in writing to the tenant from whom the unit was recovered shall give
6 rise to a presumption that the landlord did not have a good faith intention to recover the unit
7 for the stated ground.

8 (e)~~(f)~~ If possession of a rental unit is recovered as the result of any written or verbal
9 statement to the tenant that the landlord intends to recover the unit under one of the grounds
10 enumerated in Section 37.9(a) or (b), the unit shall be subject to all restrictions set forth under
11 this Chapter on units recovered for such stated purpose regardless of any agreement made
12 between the landlord or the landlord's agent and the tenant who vacated the recovered unit.
13 Any unit vacated by a tenant within 120 days after receiving any written or verbal statement
14 from the landlord stating that the landlord intends to recover the unit under Section 37.9(a) or
15 (b), shall be rebuttably presumed to have been recovered by the landlord pursuant to the
16 grounds identified in that written or verbal statement.

17 ~~(g)~~ ~~Except as provided in this subsection, it shall be unlawful for a landlord, or for any~~
18 ~~person who willfully assists a landlord, including the landlord's attorney or legal~~
19 ~~representative, to seek or obtain a tenant's agreement not to cooperate with any investigation~~
20 ~~or proceeding by any administrative or law enforcement or other governmental agency under~~
21 ~~this Chapter, or to otherwise seek or obtain a tenant's waiver of rights under this Chapter. Any~~
22 ~~waiver of rights by a tenant under this Chapter shall be void as contrary to public policy unless~~
23 ~~the tenant is represented by independent counsel and the waiver is approved in a Court-~~
24 ~~supervised settlement agreement, or by a retired judge of the California Superior Court sitting~~
25 ~~as a mediator or arbitrator by mutual agreement of the tenant represented by independent~~

1 counsel and the landlord. Any settlement agreement shall identify the judge, mediator, or
2 arbitrator reviewing the settlement, all counsel representing the parties, and any other
3 information as required by the Board. The landlord shall file a signed copy of the settlement
4 agreement with the Board within ten days of execution. Unless otherwise required by the
5 Board, the copy of the agreement filed with the Board shall redact the amount of payments to
6 be made to tenants.

7 ~~(f)(h)~~ It shall be unlawful for a landlord to knowingly fail to disclose in writing to the
8 buyer, prior to entering into a contract for the sale of any property consisting of two or more
9 residential units, the specific legal ground(s) for the termination of the tenancy of each
10 residential unit to be delivered vacant at the close of escrow.

11 ~~(g)(i)~~ It shall be unlawful for a landlord/owner, when offering a property for sale in the
12 City and County of San Francisco that includes two or more residential units, to knowingly fail
13 to disclose in writing to any prospective purchaser:

14 (1) The specific legal ground(s) for the termination of the tenancy of each residential
15 unit to be delivered vacant at the close of escrow; and,

16 (2) Whether the unit was occupied by an elderly or disabled tenant at the time the
17 tenancy was terminated. For purposes of this ~~Section~~ Section 37.10A~~(g)(i)~~, "elderly" means a tenant
18 defined as elderly by ~~San Francisco~~ Administrative Code ~~Sections~~ Sections 37.9(i)(1)(A),
19 37.9A(e)(1)(C), 37.9A(e)(2)(D), or 37.9A(e)(3)(C), or a tenant defined as "senior" by ~~San~~
20 ~~Francisco~~ Subdivision Code ~~Section~~ Section 1359(d). For purposes of this ~~Section~~ Section 37.10A~~(g)(i)~~,
21 "disabled" means a tenant defined as disabled by ~~San Francisco~~ Administrative Code
22 ~~Sections~~ Sections 37.9(i)(1)(B)(i), 37.9A(e)(1)(C), 37.9A(e)(2)(D), or 37.9A(e)(3)(C), or by ~~San~~
23 ~~Francisco~~ Subdivision Code ~~Section~~ Section 1359(d).

24 Any disclosure required by this ~~Subsection~~ Subsection ~~(g)(i)~~ that is made on a flier or other
25 document describing the property which is made available to prospective purchasers at each

1 open house and at any tour through the property will constitute compliance with the disclosure
2 requirements of this ~~s~~Subsection (g)(i).

3 (h) It shall be unlawful for any landlord, within five years after service of the notice to
4 quit under Section 37.9(a)(8), to charge a rent for the unit that exceeds the maximum rent for
5 the unit as provided in Section 37.9B(a), unless the notice of constraints on the unit has been
6 rescinded. Each month or portion thereof that the landlord charges an excessive rent in
7 violation of Section 37.9B(a) shall constitute a separate violation.

8 (i)(j) Any person who violates Section 37.10A(a), (b), ~~(c)~~, ~~(d)(c)~~, ~~(g)~~ or ~~(h)(f)~~, or (h) is
9 guilty of a misdemeanor and shall be punished by a mandatory fine of ~~one thousand dollars~~
10 ~~(\$1,000)~~, and in addition to such fine may be punished by imprisonment in the County Jail for
11 a period of not more than six months. Each violation shall constitute a separate offense.

12 13 **SEC. 37.11A. CIVIL ACTIONS,**

14 Whenever a landlord charges a tenant a rent which exceeds the limitations set forth in
15 this Chapter, retaliates against a tenant for the exercise of any rights under this Chapter, or
16 attempts to prevent a tenant from acquiring any rights under this Chapter 37, the tenant may
17 institute a civil proceeding for injunctive relief and/or money damages, and in cases where the
18 landlord has charged an excessive rent in violation of Section 37.9B(a), injunctive relief and/or
19 money damages of not less than three times the amount of excess rent collected; provided,
20 however, that any monetary award for rent overpayments resulting from a rent increase which
21 is null and void pursuant to Section 37.3(b)(5) shall be limited to a refund of rent
22 overpayments made during the three-year period preceding the month of filing of the action,
23 plus the period between the month of filing and the date of the court's order. In any case,
24 calculation of rent overpayments and re-setting of the lawful base rent shall be based on a
25 determination of the validity of all rent increases imposed since April 1, 1982, in accordance

1 with Sections 37.3(b)(5) and 37.3(a)(2) above. The prevailing party in any civil action brought
2 under this Section 37.11A shall be entitled to recover reasonable attorneys' fees and costs.
3 The remedy available under this Section 37.11A shall be in addition to any other existing
4 remedies which may be available ~~to the tenant~~.

5
6 Section 2. Effective Date. This ordinance shall become effective 30 days after
7 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
8 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
9 of Supervisors overrides the Mayor's veto of the ordinance.

10
11 Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
12 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
13 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
14 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
15 additions, and Board amendment deletions in accordance with the "Note" that appears under
16 the official title of the ordinance.
