[Urging Governor Schwarzenegger to grant parole to Flozelle Woodmore]

Resolution urging Governor Schwarzenegger to follow the Parole Board's recommendation to grant parole to Flozelle Woodmore.

WHEREAS, Flozelle Woodmore was 13 years old when she began a relationship with an abusive man who raped, burned, and beat her over a five-year period; and

WHEREAS, At the age of 18, Woodmore killed her abuser after he threatened to kill her and their son; and

WHEREAS, At the time of the incident, evidence about domestic violence, known as the "battered woman syndrome," was not recognized as a defense, and was never introduced in her case; and

WHEREAS, Woodmore plead guilty to second-degree murder and was sentenced to fifteen years to life in prison; and

WHEREAS, The Parole Board recommends release for less than 5% of eligible prisoners service life sentences; and

WHEREAS, The Parole Board members are appointed by the Governor; and WHEREAS, Woodmore has earned her GED, learned three vocational trades, and mentors other battered women who need support; and

WHEREAS, Woodmore has served nearly 20 years in prison and has been recommended for release by the Parole Board every year for the last five years; and

WHEREAS, The Parole Board unanimously determined that Woodmore would not pose a risk to public safety if she was released based on her history of being abused, her many accomplishments in prison, her widespread community support, and her lengthy disciplinary-free record in prison; and

WHEREAS, Governor Schwarzenegger has refused to grant parole to Woodmore five times; and

WHEREAS, Governor Schwarzenegger recently called a special legislative session to discuss reforms to the California prison system, including proposals to enhance rehabilitation and re-entry programs; and

WHEREAS, San Francisco Public Defender, Jeff Adachi, has been instrumental in raising awareness about Woodmore's case; now, therefore be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco urges Governor Schwarzenegger to grant parole to Flozelle Woodmore; and be it

FURTHER RESOLVED; That the Board of Supervisors urges the Governor and our representatives in Sacramento to re-commit themselves to reforming the California prison system so that it focuses on rehabilitating prisoners and helping them to successfully re-enter society upon their release.
