9 WHEREAS, The Public Library has a collection of City and County
10 of San Francisco Voter Handbooks dating from 1907 to the Present,
11 some of which are very fragile and starting to crumble; and,

12 WHEREAS, The Library seeks to preserve this valuable historical
13 archive by digitizing the documents; and,

14 WHEREAS, digitizing these historical records will enable them to
15 be accessed by researchers, historians and the public far into the
16 future; and,

17 WHEREAS, The Public Library is the depository for City and
18 County Archives; and,

19 WHEREAS, The grant budget includes provision for indirect costs
20 of \$4,000; now, therefore, be it

21 RESOLVED, That the Public Library be authorized to accept and
22 expend a grant in the amount of \$44,500 from the California State
23 Library through the Library Services and Technology Act for the
24 preservation of the City and County of San Francisco's Voter Handbook
25 collection.




