3 **Resolution appointing Elahe Enssani, term ending June 6, 2006, and Anthony**
4 **Chukwuemeka Eke, term ending June 6, 2005, to the Immigrant Rights Commission,**
5 **residency requirement waived.**

7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
8 does hereby appoint the hereinafter designated persons to serve as members of the
9 Immigrant Rights Commission, pursuant to the provisions of Ordinance No. 211-97, for the
10 term specified:

11 Elahe Enssani, succeeding Houston Zheng, seat 9, resigned, must be an immigrant to
12 the United States who is appointed in accordance with Section 4.101 of the Charter. In
13 addition, members shall have a demonstrated knowledge of and interest in the health, human
14 service, educational, or employment issues that affect immigrants residing in San Francisco,
15 for the unexpired portion of a two-year term ending June 6, 2006;

16 Anthony Chukwuemeka Eke (residency requirement waived), succeeding Jose Ricardo
17 Bondoc, seat 10, resigned, must be an immigrant to the United States who is appointed in
18 accordance with Section 4.101 of the Charter. In addition, members shall have a
19 demonstrated knowledge of and interest in the health, human service, educational, or
20 employment issues that affect immigrants residing in San Francisco, for the unexpired portion
21 of a two-year term ending June 6, 2005, and, be it

22 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 23 1. The membership of the Immigrant Rights Commission has a goal to be
24 representative of the diversity of the City and County of San Francisco.

- 1 2. Applicant Anthony Chukwuemeka Eke, new appointee, who is not resident of San
2 Francisco, is a person with experience that uniquely qualifies him/her to serve on
3 the Immigrant Rights Commission.
- 4 3. The Immigrant Rights Commission has attempted to fill the position, for which
5 Anthony Chukwuemeka Eke was nominated, with an individual who is a City
6 resident and who have the specific experience, skills, and qualifications, but has
7 been unable to do so at this time. The Rules Committee has certified that Anthony
8 Chukwuemeka Eke is qualified to serve on the Immigrant Rights Commission.
- 9 4. After exercising due diligence, the Board of Supervisors concludes that there are no
10 other possible representative, who is a resident of San Francisco and who have the
11 specific experience, skills, or qualifications possessed by these applicants, and who
12 is willing to serve on the Immigrant Rights Commission at this time; and, be it

13 FURTHER RESOLVED, That the Board of Supervisors waives the residency
14 requirement for Anthony Chukwuemeka Eke, as allowed in cases where no qualified City
15 resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that
16 requires person(s) appointed to boards, commissions, and advisory bodies established by
17 legislative act of the Board of Supervisors to be resident(s) of the City and County of San
18 Francisco.


