3 **Ordinance authorizing settlement of the lawsuit filed by Angel Nguyen against the City**  
4 **and County of San Francisco for \$1,350,000; the lawsuit was filed on December 22,**  
5 **2015, in San Francisco Superior Court, Case No. CGC-15-549555; entitled Angel**  
6 **Nguyen v. City and County of San Francisco; the lawsuit involves an alleged personal**  
7 **injury at SFGH Wellness Center.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Angel Nguyen v. City and County of  
12 San Francisco, San Francisco Superior Court, Case No. CGC-15-549555 by the payment of  
13 \$1,350,000. The lawsuit involves an alleged personal injury at SFGH Wellness Center.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 December 22, 2015, and the following parties were named in the lawsuit: Plaintiff: Angel  
16 Nguyen, Defendants: San Francisco General Hospital; City and County of San Francisco;  
17 Regents of the University of California.
