

1 [Proposition J Contract – Parking Citation Processing and Collection System]

3 **Resolution concurring with Controller's certification that citation processing and**  
4 **collection services can be practically performed by a private contractor at a lower cost**  
5 **than by City and County employees.**

7 WHEREAS, Section 10.104.15 of the San Francisco Charter allows City Departments  
8 to contract for services performed by employees subject to civil service examination when it  
9 has been determined by the Office of the Controller that can be practically performed under  
10 private contract at a lower cost to the City than similar work performed by City and County  
11 employees; and

12 WHEREAS, In 1998, the Board of Supervisors approved a four-year agreement with  
13 PRWT Services, Inc. for a Parking Processing and Collection system; and

14 WHEREAS, In 2002, the Board of Supervisors approved a two-year extension of this  
15 contract; and

16 WHEREAS, The Office of the Controller has certified that the requirements of Charter  
17 section 10.104.15 have been satisfied for Fiscal Year 2003-2004 and has determined that  
18 contracting for the services provided for under this contract is more economical than providing  
19 the same services with City and County employees; and

20 WHEREAS, The Controller's certification is on file with the Clerk of the Board of  
21 Supervisors in File No. 040430, which is hereby declared to be a part of this  
22 resolution as if set forth fully herein; and,

23 WHEREAS, On April 6, 2004 the Board of Directors of the Municipal Transportation  
24 Agency adopted Resolution 04-046; a copy of which is on file with the Clerk of the Board of  
25 Supervisors in File No. 040430, which is hereby declared to be a part of this

1 resolution as if set forth fully herein, recommending that the Board of Supervisors concur with  
2 Controller's determination; now, therefore, be it

3           RESOLVED, That the Board of Supervisors concurs with the Controller's certification  
4 that citation processing and collection services can be practically performed by a private  
5 contractor at a lower cost than by City and County employees for fiscal year 2003-04.
