3 **Motion appointing Dahianna Lopez and Paul Supawanich, terms ending March 28,**  
4 **2010, and Jay Lee, term ending March 28, 2011, to the Pedestrian Safety Advisory**  
5 **Committee.**

7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
8 does hereby appoint the hereinafter designated persons to serve as members of the  
9 Pedestrian Safety Advisory Committee, pursuant to the provisions of the Administrative Code  
10 Article IV, sections 5.20 and 5.21, for the terms specified:

11 Dahianna Lopez, succeeding Shirley Bierly, seat 8, term expired, must be  
12 representative from a public health organization, for the unexpired portion of a two-year term  
13 ending March 28, 2010; and, be it

14 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 15 1. The membership of the Pedestrian Safety Advisory Committee has a goal to be  
16 representative of the diversity of the City and County of San Francisco.
- 17 2. Applicant Dahianna Lopez, who is not a resident of San Francisco, is a person with  
18 experience that uniquely qualifies her to serve on the Pedestrian Safety Advisory  
19 Committee.
- 20 3. The Pedestrian Safety Advisory Committee has attempted to fill the position, for  
21 which Dahianna Lopez was nominated, with an individual who is a City resident and  
22 who has the specific experience, skills, and qualifications, but has been unable to  
23 do so at this time. The Rules Committee has certified that Dahianna Lopez is  
24 qualified to serve on the Pedestrian Safety Advisory Committee.

1 4. After exercising due diligence, the Board of Supervisors concludes that there is no  
2 other possible representative, who is a resident of San Francisco and who has the  
3 specific experience, skills or qualifications possessed by this applicant, and who is  
4 willing to serve on the Pedestrian Safety Advisory Committee at this time; and, be it

5 FURTHER RESOLVED, That the Board of Supervisors waives the residency  
6 requirement for Dahianna Lopez, as allowed in cases where no qualified City resident, willing  
7 to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)  
8 appointed to boards, commissions, and advisory bodies established by the legislative act of  
9 the Board of Supervisors to be resident(s) of the City and County of San Francisco.

10 Jay Lee, succeeding Dan Brook, seat 9, term expired, must represent the public at  
11 large, for the unexpired portion of a two-year term ending March 28, 2011.

12 Paul Supawanich, , succeeding William Riggs, seat 10, term expired, must represent  
13 the public at large; for the unexpired portion of a two-year term ending March 28, 2010.
