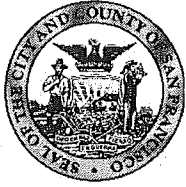
3 **Resolution approving the Terminal 1 Food and Beverage Concession Lease 7 - Lease**

9 WHEREAS, Upon completion of a competitive selection process, the Airport
10 Commission adopted Resolution No. 18-0215 on July 10, 2018, awarding the Airport Terminal
11 1 Food and Beverage Concession Lease 7 to Lady Luck Gourmet, LLC; and

12 WHEREAS, The Terminal 1 Food and Beverage Concession Lease 7 has a term of ten
13 years with one two-year option to extend, and an initial minimum annual guarantee of
14 \$240,000; now, therefore, be it

15 RESOLVED, That this Board of Supervisors hereby approves the Terminal 1 Food and
16 Beverage Concession Lease 7, a copy of which is on file with the Clerk of the Board of
17 Supervisors in File No. 181070; and, be it

18 FURTHER RESOLVED, That within 30 days of the lease being fully-executed by all
19 parties, the Airport Commission shall provide the final lease to the Clerk of the Board for
20 inclusion into the official file.


