3 **Resolution determining that the transfer of a Type 21 off-sale general license from**  
4 **667-669 Geary Street to 2480 San Bruno Avenue to Hing Yue, Inc. dba San Bruno**  
5 **Supermarket will serve the public convenience and necessity of the people of the**  
6 **City and County of San Francisco, in accordance with Section 23958.4 of the**  
7 **California Business and Professions Code, with conditions.**

9 WHEREAS, Hing Yue, Inc. is seeking transfer of a Type 21 off-sale general  
10 license for San Bruno Supermarket located at 2480 San Bruno Avenue; and,

11 WHEREAS, The Planning Department has verified that the area is properly  
12 zoned; and,

13 WHEREAS, The Police Department recommends that the liquor license  
14 application be approved with conditions; now, therefore, be it

15 **RESOLVED**, That in accordance with Section 23958.4 of the California Business  
16 and Professions Code, the Board of Supervisors of the City and County of San  
17 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21  
18 off-sale general license from 667-669 Geary Street to 2480 San Bruno Avenue for Hing  
19 Yue, Inc. dba San Bruno Supermarket, will serve the public convenience and necessity  
20 of the people of the City and County of San Francisco.

21 Conditions: (1) Sales, service, and consumption of alcoholic beverages shall be  
22 permitted only between the hours of 9:00 a.m. and 7:30 p.m. each day of the week. (2)  
23 The sale of distilled spirits in sizes small than 300ml is strictly prohibited. (3) The  
24 petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the  
25 premises over which they have control. (4) The petitioner(s) shall not permit their

1 patrons or the general public to loiter or congregate on the area adjacent to the licensed  
2 premises.


