3 Ordinance authorizing settlement of the portion of the lawsuit filed by Lawrence
4 LaBianca against the City and County of San Francisco for \$34,965; the lawsuit was
5 filed on January 31, 2005 in San Francisco Superior Court, Case No. 436930; entitled
6 Jane Martin, et al. v. City and County of San Francisco, et al.

7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. The City Attorney is hereby authorized to settle the portion of the action
9 entitled "Jane Martin, et al. v. City and County of San Francisco, et al." San Francisco
10 Superior Court, Court No. 436930, as it relates only to plaintiff Lawrence LaBianca, by the
11 payment of \$34,965, representing the claim for diminution of property value, and excluding
12 attorney's fees, costs and interest, which will be addressed in later proceedings.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiff
15 Lawrence LaBianca and Defendant City and County of San Francisco.
