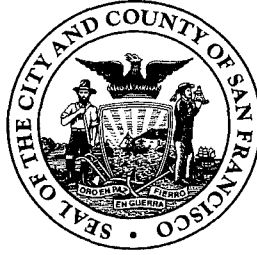

5 **California Street (District 3), will serve the public convenience or necessity of the**
6 **City and County of San Francisco in accordance with California Business and**
7 **Professions Code, Section 23958.4, and recommending that the California**
8 **Department of Alcoholic Beverage Control impose conditions on the issuance of**
9 **the license.**

11 WHEREAS, Juice Beans Brew 650, LLC, dba Hermanos Coffee & Juice Bar, is
12 seeking the issuance of a Type 40 on-sale beer license located at 650 California Street
13 (District 3); and

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero (0) protests and zero (0)
17 letters of support with the Department of Alcoholic Beverage Control under California
18 Business and Professions Code, Section 24013, and recommends that the Department
19 of Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the
21 following: 1) sales, service and consumption of alcoholic beverages shall be permitted
22 between the hours of 8:00 a.m. and 7:00 p.m. daily; 2) the petitioner(s) shall be
23 responsible for maintaining free of litter the area adjacent to the premises over which
24 they have control; 3) loitering (defined as "to stand idly about; linger aimlessly without
25 lawful business") is prohibited on any sidewalks or property adjacent to the licensed

1 premises under the control of the licensee as depicted on the ABC-257, dated
2 3/14/2017; 4) the sale of alcoholic beverages for off-sale consumption is strictly
3 prohibited; 5) the licensee(s) or an employee of the licensee(s) will monitor the outdoor
4 patio area(s) at all times that alcoholic beverages are being served or consumed, to
5 ensure that the premises will operate in compliance with all applicable laws and/or
6 conditions; and 6) sales and delivery of alcoholic beverages to and from the outdoor
7 seating area(s) will only be made by the licensee/employees; now, therefore, be it

8 RESOLVED, That in accordance with California Business and Professions Code,
9 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
10 hereby determines that the issuance of a Type 40 on-sale beer license to Juice Beans
11 Brew 650, LLC, dba Hermanos Coffee & Juice Bar, located at 650 California Street
12 (District 3), will serve the public convenience or necessity of the City and County of San
13 Francisco; and, be it

14 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
15 San Francisco hereby endorses and adopts the recommendations of the Police
16 Department listed above, and recommends that the Department of Alcoholic Beverage
17 Control issue the license with those conditions.
