1 [Traffic Regulations]

2 ENACTING AND RESCINDING TRAFFIC REGULATIONS ON VARIOUS STREETS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
4 and the San Francisco Traffic Code, the following regulations governing the movement of
5 vehicles are hereby enacted or rescinded as designated below:

6 **ONE-WAY STREET - ESTABLISH**

8 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

9 San Bruno Avenue, west side, at Mansell Street (51-foot zone between north and
10 south sections of Mansell Street)

11 **TOW-AWAY, NO STOPPING, 4 PM - 6 PM, MONDAY THROUGH FRIDAY - RESCIND**

12 Sutter Street, north side, between Gough and Octavia Streets

13 **TOW-AWAY, NO STOPPING, BEFORE, DURING, AND AFTER BALLPARK EVENTS - ESTABLISH**

14 4th Street, west side, from 3rd Street to 600 feet northerly (600-foot zone)

15 **MULTIPLE RIGHT TURN LANES - ESTABLISH**




