3 **Resolution enacting and rescinding parking regulations at various locations.**

4 RESOLVED, That, in accordance with the provisions of the California Vehicle
5 Code and the San Francisco Traffic Code, the following regulations governing the
6 parking of vehicles are hereby enacted or rescinded as designated below:

7 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

8 12th Street, east side, from 119 feet to 140 feet south of Kissling Street (between
9 the driveways of the parking garage).

10 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

11 Broadway, both sides, from Taylor Street to 250 feet westerly (legislates existing
12 conditions);

13 Broadway, south side, from Taylor Street to Himmelman Place (legislates
14 existing conditions);

15 Green Street, north side, From Taylor Street to Mason Street (legislates existing
16 conditions); and

17 Jones Street, east side, from Green Street to Filbert Street (legislates existing
18 conditions).

19 **NO PARKING ANYTIME - RESCIND**

20 Oak Street, north side, from Masonic Avenue to 200 feet westerly.

21 **TOW-AWAY NO STOPPING, 3 PM TO 7 PM, MONDAY THROUGH FRIDAY -**
22 **ESTABLISH**

23 Oak Street, north side, from Masonic Avenue to 300 feet westerly.

24 **TOW-AWAY NO STOPPING, 7 AM TO 9 AM, MONDAY THROUGH FRIDAY -**
25 **RESCIND**

Oak Street, north side, from Ashbury Street to 100 feet easterly.

ANGLE (45-DEGREE) PARKING - ESTABLISH

1 25th Avenue, east side, from Noriega Street to 90 feet northerly; and
2 25th Avenue, east side, from Noriega Street to 72 feet southerly.

3 **ANGLE (60-DEGREE) PARKING - ESTABLISH**

4 Noriega Street, south side, between 24th and 25th Avenues (replacing 45-degree
5 parking).

6 **NO PARKING 9 AM - 5 PM, EXCEPT SUNDAYS - RESCIND**

7 **NO PARKING 8 AM - 4 PM, EXCEPT SATURDAYS, SUNDAYS AND HOLIDAYS -
8 ESTABLISH**

8 Staples Street, north side, between Phelan and Hazelwood Avenues.

9 **RESIDENTIAL PERMIT PARKING AREA "W" (2-HOUR TIME LIMIT, 8 AM - 6 PM,
10 MONDAY THROUGH FRIDAY) - ESTABLISH**

11 Florida Street both sides, between 22nd and 23rd Streets (1000 block); and
12 23rd Street, both sides, between Bryant and Florida Streets (2800 block).

13 **NO PARKING 7 AM - 6 PM - RESCIND**

14 Rolph Street, south side, from Mission Street to 100 feet easterly.

15 ~~**RESIDENTIAL PERMIT PARKING AREA "S" (2-HOUR TIME LIMIT, 8 AM - 9 PM,
16 MONDAY THROUGH FRIDAY) - ESTABLISH**~~

17 ~~Hill Street, both sides, between Nee and Sanchez Streets (400 block).~~

18 **TOW-AWAY, NO STOPPING FROM 7 AM - 9 AM, MONDAY THROUGH FRIDAY -
19 ESTABLISH**

TOW-AWAY, LANE MUST TURN RIGHT - ESTABLISH

20 Irving Street, south side, from 19th Avenue to 64 feet westerly.

22 Categorically exempt from Environmental Review Class
23 1(c)(9) changes in the traffic and parking regulations
24 where such changes do not establish a higher speed
25 limit or result in more than a negligible increase in the
use of the street.

Oak Street, north side, from Ashbury Street to 100 feet easterly.

ANGLE (45-DEGREE) PARKING - ESTABLISH

25th Avenue, east side, from Noriega Street to 90 feet northerly; and
25th Avenue, east side, from Noriega Street to 72 feet southerly.

ANGLE (60-DEGREE) PARKING - ESTABLISH

Noriega Street, south side, between 24th and 25th Avenues (replacing 45-degree parking).

NO PARKING 9 AM - 5 PM, EXCEPT SUNDAYS - RESCIND

NO PARKING 8 AM - 4 PM, EXCEPT SATURDAYS, SUNDAYS AND HOLIDAYS - ESTABLISH

Staples Street, north side, between Phelan and Hazelwood Avenues.

RESIDENTIAL PERMIT PARKING AREA "W" (2-HOUR TIME LIMIT, 8 AM - 6 PM, MONDAY THROUGH FRIDAY) - ESTABLISH

Florida Street both sides, between 22nd and 23rd Streets (1000 block); and
23rd Street, both sides, between Bryant and Florida Streets (2800 block).

NO PARKING 7 AM - 6 PM - RESCIND

Rolph Street, south side, from Mission Street to 100 feet easterly.

TOW-AWAY, NO STOPPING FROM 7 AM - 9 AM, MONDAY THROUGH FRIDAY - ESTABLISH

TOW-AWAY, LANE MUST TURN RIGHT - ESTABLISH

Irving Street, south side, from 19th Avenue to 64 feet westerly.




