2 Mobile Probation Service Centers Grant Program - \$507,470]

3 **Resolution retroactively authorizing the Adult Probation Department to accept and**
4 **expend a grant in the amount of \$507,470 from the Board of State and Community**
5 **Corrections (BSCC) for the Mobile Probation Service Centers Grant Program funded**
6 **through The Budget Act of 2022 (Assembly Bill No. 178), for the period of May 1,**
7 **2023, through September 30, 2027.**

9 WHEREAS, The County of San Francisco desires to participate in the Mobile
10 Probation Service Centers Grant Program funded through the State Budget Act of 2022
11 and administered by the BSCC; and

12 WHEREAS, The Mobile Probation Service Centers Grant Program funds vehicles,
13 equipment, telecommunications and other technology needed to operate mobile probation
14 service centers to assist probationers, particularly those individuals who are unhoused and
15 struggling with meeting probation requirements; and

16 WHEREAS, The Mobile Probation Service Center Grant Program will target high
17 poverty areas with 20% or more people who fall below federal poverty levels (i.e. zip codes
18 94102, 94103, and 94124); and

19 WHEREAS, 46% of the Adult Probation Department clients are located in these
20 areas; and

21 WHEREAS, Grant funds will be used to purchase and outfit two vans to serve as
22 Mobile Probation Service Centers to increase accessibility and engagement in services for
23 unhoused clients; and

24 WHEREAS, The grant does not require an amendment to the Annual Salary
25 Ordinance; and

WHEREAS, The grant does not require matching funds; and
WHEREAS, Indirect costs are not an eligible grant expense; now, therefore, be it
RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs
in the grant budget; and, be it

FURTHER RESOLVED That grant funds received hereunder shall not be used to
supplant expenditures controlled by this body; and, be it

FURTHER RESOLVED That the County of San Francisco agrees to abide by the
terms and conditions of the Grant Agreement as set forth by BSCC; and, be it

FURTHER RESOLVED, That the Board of Supervisors hereby
authorizes the Adult Probation Department’s Chief Probation Officer to submit the grant
proposal for this funding and sign the Grant Agreement with BSCC for grant funds in the
amount of \$507,470 for the period of May 1, 2023, through September 30, 2027.
