5 OF OPERATION OF THE CIVIL SERVICE MERIT SYSTEM IN THE CITY AND

8 WHEREAS, The San Francisco Civil Service Commission was established in 1900,
9 the same time as the merit system for the City and County of San Francisco was established;
10 and

12 WHEREAS, The Civil Service Commission was one of the first in the country and
13 San Francisco had the first civil service system West of the Mississippi; and

14 WHEREAS, The Commission formally organized on January 5, 1900, with the
15 election of its president from three members appointed by Mayor James D. Phelan; and

16 WHEREAS, The first competitive examination was held on January 8, 1900; and

18 WHEREAS, The Civil Service Commission has performed its charge to oversee,
19 regulate, and serve as final arbiter of the City and County of San Francisco civil service merit
20 system; and

21 WHEREAS, The Civil Service Commission has established, ensured and maintained
22 an equitable and credible merit system for public service for the citizens of San Francisco; and

24 WHEREAS, In the 100 years of its operation, the Commission has responded to the
25 changing needs of personnel management through an effective, fair and modern system that

recognizes and builds on the diversity, skills and dedication of public employees, and consistently provides the best qualified candidates for public service in a timely and cost effective manner; now, therefore, be it




