Resolution authorizing the Mayor's Office of Criminal Justice to retroactively accept and expend a grant in the amount of \$200,000 from the State Corrections Standards Authority for the purpose of implementing the Read Into Your Future Project through the Title II Formula Grant Program, for the period from April 1, 2006 to March 31, 2007.

WHEREAS, the Mayor's Office of Criminal Justice (MOCJ) desires to undertake a certain project, designated the Read Into Your Future Project, to be funded in part from funds made available through the Title II Formula Grants Program administered by the Corrections Standards Authority (CSA); and

WHEREAS, the grant budget includes a provision for indirect costs of \$10,000; now, therefore be it

RESOLVED, that the Director of MOCJ is authorized, on its behalf to submit the attached proposal to CSA and is authorized to sign and approve on behalf of the City and County of San Francisco the attached Grant Award Agreement including any extensions or amendments thereof; and

IT IS AGREED that any liability arising out of the performance of this Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and CSA disclaim responsibility for any such liability.

BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.






